DIRECTIVE ON TUITION, FEES AND REFUND POLICY

1. The student is obliged to pay the tuition fees and fees within the set due dates.
2. The due date is considered to be the day of crediting the payment to the MIA account in accordance with § 567 (2) of Act no. 40/1964 Coll. (Civil Code).
3. This Directive is binding on all students, teachers and staff who provide, organize and complete studies at MIA.

Tuition fee

1. Tuition fee is a financial contribution of a student to cover part of the costs associated with his / her studies at Mondo International Academy.
2. The amount of the tuition fee is approved by the Board of Directors.
3. The tuition fee must be paid after the decision on admission to the Mondo International Academy has been taken.
4. The tuition fee is always 7 days after the signature of the student contract.

Paying tuition

1. The student pays tuition according to the contractual agreement
2. When enrolling for a new academic year, the student is obliged to submit proof of payment of tuition for the semester no later than one the day before the semester starts. If the student has financial obligations from previous academic years, he is obliged to prove their payment no later than on the day one the day before the semester starts.

3. If a student leaves or interrupts his / her studies at Mondo International Academy, he / she is obliged to pay the full tuition fees.
4. If a student fails to pay tuition fees within the required time limit, the Academic director may invite him / her to appear in person to discuss issues relating to his / her studies and study obligations.
5. In the case of the Student's delay in the payment of the invoiced amount, MIA has the right to charge interest on late payment of 0.05% of the invoiced amount for each day of delay.
6. Failure to pay the tuition fee for the relevant instalment and the relevant fees is a disciplinary offense and a reason for expulsion from studies.

Tuition relief

1. In cases worthy of special consideration (social and health situation of the student), a student may submit an application for a reduction of tuition fees or its distribution in instalments together with credible documents confirming the legitimacy of his application at the directorate of Mondo International Academy.
2. The authorized person examines the students' applications and decides on their approval or rejection.

Study-related fees

Definition and scope

The rules for the reimbursement of students' funds are part of the academy's student protection plan, which the school is required to publish as a higher education provider. The student protection plan sets out the potential risks to continuing studies and the College's position on reimbursements and compensations, if any.

This student compensation and reimbursement policy applies to situations where Mondo International Academy is no longer able to continue providing studies for one or more students, for example:

- Closure of Mondo International Academy as a whole, permanently
- Loss of validity without proper alternative

Tuition refund amount

The Academy supports its students in achieving their academic potential and required for a successful career. The Academy also undertakes to ensure that, in the event of closure of studies due to loss of accreditation or the closure of the Academy as a whole, all students may, as far as possible, continue and complete their studies at another College or university to "study" and continue the program, which was closed. Students as well as applicants who have obtained a place of study in the relevant program should take appropriate steps to alleviate the situation in accordance with any advice provided by the school.

Reasons for non - refund of tuition fees

1. Leaving unfinished studies at the student's own discretion is not a reason to refund tuition fees.
2. In cases worthy of special consideration, the school principal of Mondo International Academy Bratislava or a person authorized by him shall decide on the return of the study fee.

The fees paid by the Student may not be recovered. The paid fee cannot be reimbursed on the basis of the student's status being paused or terminated, and forfeits the right to get accounted about any paid tuition fees.
